# **RESOLUITION No. 2025-17**

Ratification Declaration of Disaster Emergency – Crozer Health System Closure

WHEREAS, on April 29<sup>th</sup>, 2025, Board of Supervisors Chair Chuck Dennie executed a declaration of disaster emergency in response to the bankruptcy of Prospect Medical Holdings, parent company of Crozer Health, and its effect on healthcare and emergency services within Bethel Township and throughout Delaware County (the "Declaration");

**WHEREAS**, pursuant to 35 Pa.C.S. § 7501(b), a disaster emergency declaration is valid for a maximum of seven (7) days except as may be extended by the governing body of a political subdivision;

WHEREAS, this Board hereby determines that the disaster emergency underlying the Declaration will last for an indeterminate amount of time.

**NOW, THEREFORE,** be it **RESOLVED** that the Declaration is hereby ratified, and the disaster emergency shall remain in place until revoked by action of this Board of Supervisors.

# **DECLARATION OF DISASTER EMERGENCY**

I, Chuck Dennie, Chair of the Board of Supervisors of Bethel Township, Delaware County, Pennsylvania, do hereby declare a Disaster Emergency exists for said Township, pursuant to the authority vested by the Pennsylvania Emergency Management Services Code, P.L. 1332, November 26, 1978, as amended, 35 Pa.C.S.A. § 7501(b), due to the impending closing of the Crozer Health system and the cessation of Crozer Health providing emergency medical services throughout Delaware County. This declaration shall remain in effect until revoked by me in writing, or for seven (7) days, unless revoked or extended by a majority of the Bethel Township Board of Supervisors.

The emergency provisions of the Pennsylvania Emergency Management Services Code relating to contracts and obligations (35 Pa.C.S.A. § 7501(c)); the temporary suspension of formal requirements (35 Pa.C.S.A. § 7501(d)); and the employment of personnel (35 Pa.C.S.A. § 7501(e)) are hereby enabled.
